TERMS OF USE OF TIQ 2 WEBSITES

These Terms of Use apply on each and every use by any visitor and/or user of any of the TIQ 2 Websites (as defined below), operated by TIQ 2 SA, a Swiss company with its principal place of business in Nyon, Switzerland ("TIQ 2").

TIQ 2 operates websites (collectively "TIQ 2 Websites"). By using TIQ 2 Websites and any services accessible from TIQ2 Websites, the visitor/user (further: "you") agrees to be bound by the following terms and conditions ("Terms of Use"). If you do not agree to these Terms of Use, you may not visit or use any of TIQ 2 Websites, and you are required to leave all TIQ 2 Websites.

Ownership of content

The copyright on the content of any of the TIQ 2 Websites, and all TIQ 2 trademarks appearing on TIQ 2 Websites, belong to TIQ2 or its licensors. All intellectual property rights on content, names, logos and other trademarks are protected under national and international copyright, patent and trademark laws, international conventions and all other relevant intellectual property and proprietary rights and applicable laws. You therefore may for example not use or reproduce any graphics, audio or video, photographic or other content from any of the TIQ 2 websites without prior specific written consent of TIQ 2.

Privacy

By using any of the TIQ 2 Websites, you acknowledge irrevocably that you have read and that you do accept TIQ 2's Privacy Policy. You consent to the processing of your personal data by TIQ 2 and/or its assignees in accordance with that Privacy Policy Statement.

General practices regarding use; Acceptable use policy; Breach

TIQ 2 reserves the right to limit, suspend or terminate your access and use of TIQ 2 Websites at any time without notice. TIQ 2 makes no guarantee that any TIQ 2 Website will be uninterrupted or error free. TIQ 2 reserves the right to suspend or withdraw the whole or any part of any TIQ 2 Website at any time without notice and without incurring any liability.

You may create links to TIQ 2 Websites from other respectable websites. You may not create links to TIQ 2 Websites from any racist or extremist website or any website advocating hatred, violence or discrimination. Use. You acknowledge that TIQ 2 has no obligation to pre-screen or monitor your access to or use of TIQ 2 Websites or any information, materials or other content provided or made available through TIQ 2 Websites, but has the right to do so. You hereby agree that TIQ 2 may, in the exercise of TIQ 2' sole discretion, remove or delete any entries, information, materials or other content that violates these Terms of Use.

Your account

You may visit any of the TIQ 2 Websites without having an account with TIQ 2. In order to open an account on TIQ 2 Websites and services available on TIQ 2 Websites, you must register ('Sign up') with TIQ 2 and provide any information required by TIQ 2 during the registration process. You are responsible for maintaining the accuracy of this information, and for the security of your account and password. TIQ 2 will not be liable for any loss or damage arising from your failure to comply with this responsibility. You are also responsible for any content that you may post on TIQ 2 Websites and for all activity that occurs under your account. Your account is personal and may not be used by third parties. You must: (i) notify TIQ 2 immediately of any unauthorized use of any password or Account or any other known or suspected breach of security; and (ii) use reasonable efforts to stop immediately any unauthorized activity that is known to or suspected by you.

Prohibited use

You may not:

- upload, post, email, transmit or otherwise make available any information, materials or other content that is illegal, harmful, threatening, abusive, harassing, defamatory, obscene, pornographic, racist, extremist or offensive; that advocates violence; or that infringes another's rights, including any intellectual property rights;
- use any TIQ 2 Website:
 - for any fraudulent purpose or to any fraudulent effect
 - for the purpose of harming or attempting to harm minors in any way
 - knowingly transmit any data, send or upload any (material that contains) viruses, Trojan horses, worms, time-bombs, keystroke loggers, spyware, adware or any other harmful programs or similar computer code designed to affect adversely the operation of any computer software or hardware.
- impersonate any person or entity or falsely state or otherwise misrepresent your affiliation with a person or entity;
- obtain, collect, store or modify personal information about other users without prior written consent;
- upload, post, email, transmit or otherwise make available any unsolicited or unauthorized advertising, promotional materials, "junk mail," "spam," "chain letters," "pyramid schemes," or any other form of solicitation;
- modify, adapt or hack TIQ 2 Websites or falsely imply that some other Website is associated with TIQ 2 Websites or TIQ 2;
- access without authority, interfere with, damage or disrupt:
 - any part of a TIQ 2-website,
 - any equipment or network on which a TIQ 2-website is stored,
 - any software used in the provision of a TIQ 2-website, or
 - any equipment or network or software owned or used by any third party; or
- use any TIQ 2 Website for any illegal or unauthorized purpose;

- during any use of any of the TIQ 2 Websites, violate any laws in any relevant jurisdiction. Recognizing the global nature of the Internet, you will comply with all local rules regarding online conduct.

Comments

In the course of using TIQ 2 Websites, you may provide TIQ 2 with comments, including but not limited to suggestions and observations concerning errors, problems and defects, as well as any other issues, regarding any of the TIQ 2 Websites. You hereby grant TIQ 2 a worldwide, irrevocable, perpetual, non-exclusive, royalty-free, transferable and sub-licensable right to use, copy, modify, distribute, display, translate, perform, create derivative works from, sub-license and otherwise exploit any and all such comments.

Any dispute shall be submitted to the exclusive jurisdiction of the court competent in the place of business of TIQ 2. Any failure of TIQ 2 to exercise or enforce any right or provision of these Terms of Use shall not constitute a waiver of such right or provision. If any provision of these Terms of Use is found by a court of competent jurisdiction to be invalid, TIQ 2 may in a different way give effect to her intentions as reflected in the provision, and the other provisions of these Terms of Use remain in full force and effect. The section titles in these Terms of Use are for convenience only and have no legal effect.

GENERAL TERMS OF TIQ 2 CONCERNING ONLINE BOOKING

Anybody making a booking through TIQ 2 is bound to these General Terms plus to the Clubs' or Trainer' Terms. "Club or Trainer" is any training establishment or educational establishment (all in the widest sense), and "Clubs' or Trainer' Terms" are its Terms & Conditions which are applicable on any dealing with that establishment, for instance holding a cancellation policy of the Club or Trainer in effect at the time of the online booking. The online booking service provided by TIQ 2 is free for Participants and Parents. For Clubs and Trainers, please refer to the specific Terms and Conditions.

The person who takes part, or intends to take part, in a course that is the object of a booking is the "Participant"; if the Participant has not reached the age of 18, the booking must be done or approved by his parent or guardian, who must also give his or her exact address. This shall also apply when the age of consent is not 18 years in the country where the course is taking place, or in which the Participant or his or her parent or guardian is resident.

Information provided upon sign up and booking

The Participant will provide truthful information at the time of booking; the Participant may be expelled forthwith from the course at any time should said information prove to be a misrepresentation. Participants who are unsure of their language level should contact TIQ 2.

Clubs and Teachers

TIQ 2 will present Clubs and Trainers in a way that comparison of the offering is easy for the consumer, ie. the Participant and/or Parent. TIQ 2 will endeavour to present information on the profile, facilities, activities, courses, accommodations and transfers, terms and conditions, plus links to the Club or Trainer website and email-address.

Booking a course

Once any course is chosen by the Participant, the Participant can then book the course immediately through TIQ 2.

The booking may be rejected and/or not executed by either TIQ 2 or the Club for the following reasons:

- The booking is made by an under aged Participant without the consent from his Parent or guardian;
- The Participant does not send documents requested in time;
- The Participant does not make payment by the requested date;
- The Participant cannot be reached for more than one month;
- The Participant provided untruthful information during the online booking;
- The course is over subscribed, not running or deemed unsuitable for the Participant;
- There are practical reasons for rejection of the booking;

The booking is deemed to be unsuitable for any other reasons.

Once a booking is received, TIQ 2 will email a confirmation of the booking. Acceptance by the Club or Trainer leads to a contract between the Participant and the Club or Trainer, on which the Club's and Trainer's Terms are applicable. TIQ 2 is not a party to that contract. TIQ 2' role is solely that of facilitator. TIQ 2 carries an obligation to make her best effort, not an obligation to procure any result. TIQ 2' system enables the Participant to communicate with the Club and Trainers. TIQ 2 will request the Club to send all necessary documents directly to the Participant.

Payment

TIQ 2 will assist the Participant to make his payment directly to the Club or Trainer by providing all information necessary thereto. TIQ 2 is not an intermediary for the payment of the course fees. Payment must be made to the Club or Trainer by the Participant in accordance with the Club's terms.

Changes of Terms

TIQ 2 reserves the right to change these Terms.

Cancellation and refund

After making the booking, cancellations are governed by the Clubs' and Trainer's Terms.

Booking process

If a booking cannot be processed or executed due to the Participant's incompliance with the Clubs' or Trainers' Terms, the Participant is liable for the charge depicted in the Clubs' or Trainers' Terms.

Disclaimer

TIQ 2 is not liable or responsible in case:

- the Club or Trainer decides to stop or change the course;
- the Participant is unable to attend the course for personal reasons;
- the Club or Trainer has supplied inaccurate information to TIQ 2 which leads to inaccurate information by TIQ 2.
- of any other reasons out of TIQ 2' control.

Damages

TIQ 2 is not liable for any damages caused to or by the Participant and/or Parent, nor for damages causes to or by the Club and/or Trainer.

Applicable law and Jurisdiction

These Terms are governed by the laws of Switzerland. All disputes arising out of or in connection with these Terms shall be subjected to the exclusive jurisdiction of the courts of TIQ 2' place of business. However, TIQ 2 may seek emergency relief before any competent court or tribunal in the event of a breach or anticipated breach of these Terms.

Data protection
